

How to Report Emergencies and Safety Concerns at KSC



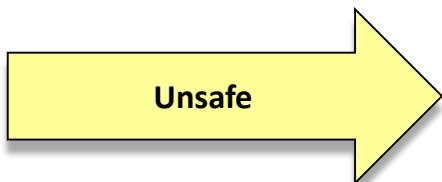
Life threatening or urgent injury/situation
<ol style="list-style-type: none">1) Call 9-1-1 or 321-867-7911 (cell phone), or 321-853-0911 (at CCSFS)2) If injury occurs, notify injured employee's supervisor3) Then notify:<ol style="list-style-type: none">a. For a federal employee injury, call 7-SAFE (321-867-7233)b. For a contractor injury, notify employee's organizational safety office



Non-urgent injury
<ol style="list-style-type: none">1) Go to the Occupational Health Facility (OHF)<ul style="list-style-type: none">• If the OHF is closed, call Emergency Medical Services: 9-1-1 or 321-867-7911 (cell phone), or 321-853-0911 (at CCSFS)2) Notify injured employee's supervisor3) Then notify:<ol style="list-style-type: none">a. For a federal employee injury, call 7-SAFE (321-867-7233)b. For a contractor injury, notify employee's organizational safety office



Imminently Dangerous Situation
<ol style="list-style-type: none">1) Use your Stop Work Authority if you believe a time-out is needed2) Work with management to determine how to eliminate/mitigate the hazard3) Then notify:<ol style="list-style-type: none">a. If the situation involves a federal employee, call 7-SAFE (321-867-7233)b. If the situation involves a contractor, notify employee's organizational safety office4) If you prefer to report electronically/anonymously, click here5) When in doubt, call 7-SAFE (321-867-7233)

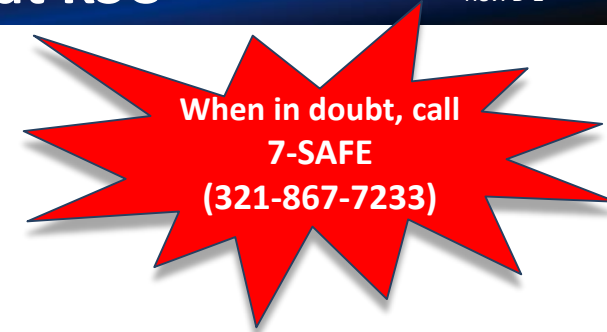


Unsafe Activity or Condition
<ol style="list-style-type: none">1) If you can do so safely, stop the unsafe activity/condition2) Work with management to determine how to eliminate/mitigate the hazard3) Then notify:<ol style="list-style-type: none">a. If the situation involves a federal employee, call 7-SAFE (321-867-7233)b. If the situation involves a contractor, notify employee's organizational safety office4) If you prefer to report electronically/anonymously, click here5) When in doubt, call 7-SAFE (321-867-7233)
